I further understand that this temporary "delegation" of my parental power does not relieve me of the primary responsibility of my (daughter/son)

GIVING AND GRANTING until said GUARDIAN full power and authority to do, take and perform all and every act in think whatsoever requisite, power or necessary to be done, in the exercise of any of the rights and powers herein granted, as fully to all intents and purposes for the benefit of my said (son/daughter), as I might or could do if personally present, hereby ratifying and confirming all that the said guardian shall lawfully do or cause to be done by virtue of this delegation of powers and the rights and powers herein granted.

The above delegation of powers of the GUARDIAN herein granted shall commence and be in full force and effect on the date set forth below, and such powers shall remain in full force and effect from _____ until _____, but no longer than ONE YEAR from the date set forth below.
